### Introduction

The eSkills Malta Foundation brings together a coalition of representatives of the Ministry of Education, the Malta Information Technology Agency, Malta Enterprise, the Malta Communications Authority, the Malta Gaming Authority and the Chamber of Commerce Enterprise and Industry.

The Foundation is a multi-stakeholder partnership with a mandate to:

- advise Government and stakeholders on matters related to e-skills policy;
- contribute to the expansion of ICT educational programmes and related formative initiatives;
- lead an ICT professionalism development programme;
- instigate further reform in the ICT educational offerings and contribute to capacity-building in the ICT education community; and
- champion campaigns and promote the Maltese potential locally and internationally.

The mandate also allows for additional subcommittees to be set up to represent the views of other stakeholders and together create a stronger synergised network of partners who can work collectively to implement more holistic programmes. 2015 was another successful year for the Foundation. The Foundation focused on increasing awareness of its activities among students and student representative bodies and reaching out to the public through targeted messages on the social media. The Foundation also participated in career oriented events organised by the Malta College of Arts, Science and Technology (MCAST) and the University of Malta.

During 2015, the eSkills Malta Foundation, together with MCAST, joined thousands of other participants coming from various countries across Europe in a week of activities on coding. As the National Contact Point for the eSkills for Jobs 2015 project, the Foundation promoted and coordinated Malta's participation in the eSkills for Jobs ICT Competition. 2015 proved to be a very successful year in terms of Malta's participation in competitions with the Maltese student body ICTSA winning the Digital Entrepreneurship category.

The Foundation is looking forward to 2016 which will undoubtedly be a very challenging but hopefully successful year. It will continue to deliver a programme of events and communication activities to inform students, unemployed persons, ICT professionals and SMEs about the vast range of opportunities presented by ICT related jobs.

Looking ahead at 2016, we will continue to broaden and raise awareness of e-skills through dialogue with key stakeholders and through engagement in partnerships which will allow the pooling of resources, expertise and experiences with other collaborating countries. I consider such alliances to be extremely valuable as they provide unique opportunities to strengthen our mutual understanding of key issues so that together we can deliver real solutions.

## Promoting eSkills through Events

In 2015, the Foundation selected a number of key themes for activities that champion and promote eSkills with a special emphasis on the take up of ICT skills by students.

### eSkills Malta Foundation and eSkills for Jobs official supporters of IDC ICT Leadership Forum

The eSkills Malta Foundation is proud to have been one of the Official Supporters of the IDC ICT Leadership Forum - The Smart IT Buyer Tour 2015. The Forum discussed how the effective use of technologies, including cloud, mobility, virtualisation, big data analytics, telecommunications and social media can help organisations to survive and succeed in the current business environment. The eSkills Malta Foundation engaged with the Maltese business community and provided it with information about its mandate and projects. One of the promoted projects was the Career Exposure Experience that the Foundation coordinates in collaboration with the Ministry for Education and Employment.

eSkills Malta Foundation representatives highlighted the current trends and challenges that the business community is facing when it comes to recruiting professionals with adequate skill sets. The realities of the digital transformation and the need for more e-leadership related initiatives were also discussed.



#### Participation of eSkills for Jobs Malta at the MCAST EXPO 2015

eSkills for Jobs Malta participated at the fourth edition of MCAST EXPO 2015. This four-day event was held between Wednesday 24th June and Saturday 27th June 2015 at the Institute of Applied Sciences at the MCAST's Main Campus in Paola. The Foundation's stand featured the theme 'Digital Skills for Tomorrow's Jobs' and focused on the promotion of standard ICT career profiles.

#### Introducing University students to the eSkills Malta Foundation

Once again the Foundation and the ICT Students Association (ICTSA) joined forces at the University of Malta Freshers' Week to promote ICT Careers and provide students with information on the Foundation's goals and mission. Freshers' Week also served as good promotion for the Foundation's upcoming events. This was the second time the Foundation participated in Freshers' Week.

### Foundation joins the rest of Europe in Codeweek 2015

Coding is becoming a key competence which will have to be acquired by all young students and increasingly by workers in a wide range of industries and professions. The EU Code Week was launched in 2013 by the Young Advisors for the Digital Agenda. The European Commission supports EU Code Week as part of its strategy for Digital Single Market.




The third edition of EU Code Week was held between 10th and 18th October 2015. Forty eight countries participated in the event. Apart from programming events in the twenty eight EU Member States, other events were held in Albania, Australia, Bosnia and Herzegovina, China, Egypt, the Former Yugoslav Republic of Macedonia, Iceland, Korea, Kosovo, Moldova, Morocco, Norway, Russia, Serbia, Switzerland, Tunisia, Taiwan, Turkey, Ukraine and the US. Millions of children, young adults, adults, parents, teachers, entrepreneurs and policy makers came together in events and classrooms to learn to create with code.

In Malta, the eSkills Malta Foundation, in collaboration with MCAST, organised a series of short courses on various subjects such as how to develop your first mobile app, how to build a site or blog, how to design a logical network and also on how to use Python and C#. These eight sessions were open to all those who have basic computer skills and were held free of charge. The sessions were well attended and the participants were presented with a certificate of attendance.

### ICT Career Exposure Experience Week 2015 - 2016

The eSkills Malta Foundation, in collaboration with private and public organisations, offered 14 to 15 year old ICT students a one-week work exposure opportunity during 2015. The Foundation secured over 100 placements in 2015. This initiative aims to give these Form 4 students a taste of what it is like to be part of a vibrant ICT sector. The Foundation believes that exposure to the real dynamic working world could be instrumental in the students' future decisions and skills-set acquisition. The initiative is organised by the eSkills Malta Foundation together with the Education Psycho-Social Services Section within the Ministry for Education and Employment. Organisations had the flexibility of hosting the students during any week between 16 November 2015 and 13 May 2016. This initiative presents a unique opportunity for ICT organisations to fulfil their corporate social responsibility by offering to help entice young people to become the next generation of ICT practitioners with the much sought after skills-set.





#### **ICT in Education - School Visits**

The eSkills Malta Foundation, in collaboration with MITA, organised a number of school visits. Over 500 students hailing from 25 state, church and independent schools were hosted at the MITA Data Centre. The main purpose of these visits was to encourage the take up of ICT and to increase the students' interest in Information Technology. The visits gave students from the secondary education sector the opportunity to tour Malta's vital network operations hub and the government help desk and call centre. The students were also briefed on networking infrastructure, the 'StopHate' campaign and careers at MITA.

#### eSkills for Jobs 2015

The eSkills Malta Foundation is the National Coordinator of a European wide eSkills for Jobs campaign spanning 2015/2016. It is working together with the Government, industry and stakeholders to promote the EU eSkills strategy to fill digital skills shortages, gaps and mismatches, promote the adoption of best practices, tools and solutions and foster eLeadership and ICT professionalism. The main focus of the campaign, which is running in 21 European countries, is to raise awareness of the education, training, jobs and other opportunities that are available to people with e-skills, that is, people who know how to use digital technologies effectively. The participating countries are Austria, Belgium, Bulgaria, Croatia, Cyprus, Czech Republic, Germany, Greece, Hungary, Ireland, Italy, Latvia, Lithuania, Malta, the Netherlands, Poland, Romania, Slovakia, Slovenia, Spain and the UK.

The main aim of the campaign is to raise awareness of the need for citizens to improve their information and communication technology (ICT) skills in their place of work. It is a response to the growing demand for ICT-skilled professionals which is currently not being met. Employers are constantly struggling to find employees with the right ICT competencies for positions across the board and many students entering the market are unaware of the huge range of ICT jobs available in different industries, ranging from designers of games to programmers. Europe, including Malta, might face a shortage of up to 825,000 ICT professionals by 2020, risking its potential for growth, social cohesion and digital competitiveness. The demand for ICT professionals is always on the rise, but the number of people graduating in computer studies, maths, science, technology and engineering is actually falling across Europe.

E-skills are vital for professionals working in small to medium sized companies, for youths and the unemployed looking to enter the workforce. They are also important for companies that need a highly skilled workforce. At this point in time, e-skills are more crucial than ever to help get Europe's economy back on its feet. People with strong e-skills will also play a central role in making Malta an innovative and competitive country.

The campaign was launched under the European Commission's Grand Coalition for Digital Jobs, a multi-stakeholder partnership to address the shortfall in e-skills among Europeans and to encourage people to fully exploit the potential employment opportunities that ICT provides, while also ensuring that women are able to partake equally in the opportunities offered by the digital economy.







#### Malta Winner of the digital Entrepreneurship Category

"The eSkills Digital Entrepreneurship award is meaningful in the sense that it translates into recognition on a national and European level. We know that Europe is currently lacking in the innovation it needs to remain competitive to compete with other large economies. This is a problem we must not take lightly and as Europeans, it is our duty to take a proactive stance on this issue.

I have been serving the ICTSA executive for three semesters and as president of this

organisation, I have witnessed a high rate of student engagement when it comes to the entrepreneurial competitions and initiatives that we organise. I believe that, to have a winning team, it must be equipped with members from different backgrounds with different expertise. This motivation showed in all the events we organised, and so far we have witnessed levels of success which I have no doubt will continue to improve. This is the mentality that we, as Europeans, need to instil in our policy makers, NGOs and youth. The eSkills for Jobs 2015 European competition is organised within the context of the eSkills for Jobs awareness raising campaign. The European Competition is an opportunity to highlight and reward persons with a high level of digital skills and literacy at a European level.

In 2015, the competition was divided into 5 categories:

- Digital Citizenship;
- Digital Entrepreneurship;
- Career Campaigner;
- Young Digital Talent Competition;
- Outstanding use of ICT for teaching.

The ICT Student's Association (ICTSA) were the winners of this year's Digital Entrepreneurship Category. ICTSA is a student organisation which represents all students studying an ICT course based at the University of Malta. For the second year running, ICTSA took part in the eSkills for Jobs competition and used this platform to showcase the work it does as an organisation throughout the year. ICTSA strongly believes in the potential of students and young adults and it has provided a framework to empower Malta's youth through digital e-skills and entrepreneurial flair over a five year-long project.

ICTSA's mission is to bridge the gap between students and the industry and it has witnessed a high engagement with students especially when the students are made aware of the opportunities they can exploit when equipped with the right e-skills.

The Digital Entrepreneurship category was open to entrepreneurs working on creative entrepreneurial projects building on ICT tools and/or media and e-skills. In this category each participant had to submit a video presenting an entrepreneurial project using ICT tools and/or media.

The winners were announced during the eSkills and Ada Awards Dinner held in Luxembourg on the 14 December 2015. Etienne Buttigieg, ICTSA's Honorary President who at the time was a final year student reading for a Bachelor in IT studying Computing and Business was in Luxembourg to receive the award.

#### **Mission statement**

#### Administrators

In accordance with the company's Articles of Association, the present administrators remain in office.

#### Administrators' responsibilities

The deed of the foundation requires the administrators to prepare the financial statements for each financial year which give a true and fair view of the state of the affairs of the company and of the profit or loss of the foundation for that year, in accordance with the requirements of International Financial Reporting Standards as adopted by the EU. In preparing these the administrators are required to:

- adopt the going concern basis unless it is inappropriate to presume that the foundation will continue in business;
- select suitable accounting policies and apply them consistently;
- make judgements and estimates that are reasonable and prudent;
- account for income and charges relating to the accounting period on the accruals basis;
- value separately the components of asset and liability items; and
- report comparative figures corresponding to those of the preceding accounting period.

The administrators are responsible for keeping proper accounting records which disclose with reasonable accuracy, at any time, the financial position of the foundation and to enable them to ensure that the financial statements comply with the International Financial Reporting Standards. They are also responsible for safeguarding the assets of the foundation and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

#### Auditors

The auditors, Nexia BT, have intimated their willingness to remain in office and a resolution proposing their reappointment will be put before the Committee of Administrators at the next annual general meeting.

Independent Auditors' Report To the Members of eSkills Malta Foundation

We have audited the accompanying financial statements of eSkills Malta Foundation, which comprise the Statement of Financial Position as at 31 December 2015, and the Statement of Profit or Loss and Other Comprehensive Income, Statement of Changes in Equity and Statement of Cash Flows for the year then ended, and a summary of significant accounting policies and other explanatory notes.

#### Administrators' Responsibility for the Financial Statements
